The Vevay Town Council met in a public meeting September 2<sup>nd</sup> at 4:30pm. Council members Keith Smith, Jeremy Harsin and Lane Penick were present.

Penick motioned to approve the August 5th meeting minutes, Smith seconds motion, all in favor 3-0.

Penick motioned to approve claims register, Smith seconds, all in favor 3-0.

Lexipol resubmitted their proposal for police SOPs with a 25% discount for \$2,424.75 to be within the police budget. Penick motioned to accept quote, Smith seconds, all in favor 3-0.

Erin Thomas with Lifetime Resources requested \$5,000 for their 2026 budget. Request tabled, but will put \$5,000 request into the 2026 town budget.

Mary Lee Tolbert & Lucinda Mangold with First Financial Bank presented the Work Life Program checking account for town employees if they want to open a new account. It is optional to the employee. Keith motioned to approve program, Penick seconds, all in favor 3-0.

Penick motioned to accept quote from Structured Inc to add additional camera to Ogle Park, Smith seconds, all in favor 3-0.

Chris Hammer with the Lt. Governor Micah Beckwith's Office asked to use Town Hall to host mobile office hours in Vevay (Switzerland County) on November 18<sup>th</sup>. Council denied request and recommended them to use the Library or TEC building.

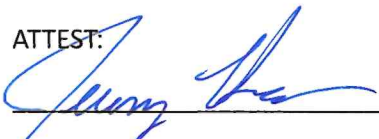
Clerk requested a budget working session on Sept 16<sup>th</sup> at 4:30.

Council members Keith Smith, Jeremy Harsin, Lane Penick were present. Clerk Brandi Scudder and John Roach were also in attendance.

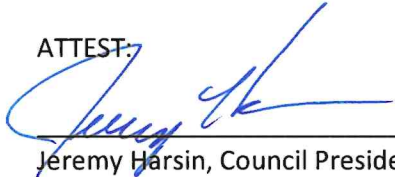
